Demonstrated evidence of excellence in undergraduate teaching is preferred.

**Description of Duties:** Normal duties related to the design and teaching of a university credit course, including preparation and delivery of course content; development, administration and marking of assignments, tests, midterm, final exams; calculation and submission of grades; holding regular office hours. Supervising the TA (if applicable).
