**Relevant Criterion:** Past teaching experience is the more relevant criterion than the need to acquire experience in respect of this posted position.

**Description of Duties:** Normal duties related to the design and teaching of a university credit course, including preparation and delivery of course content; development, administration and marking of assignments, tests and exams; calculation and submission of grades; holding regular office hours. Supervising the TA (if applicable), preparing and supervising tests and exams. The delivery method for this course is currently in-person.
